Welcome, and thank you for your interest in Sparrow Acoustics Inc. ("Sparrow Acoustics" "we," "us," or "our") and our website at stethophone.com, stethophone.freshdesk.com and support.stethophone.com (together - the "Site"). These Terms of Use (as defined below) govern only your use of the Site and not any of our products or services. These Terms of Use (or "Terms") are a legally binding contract between you and Sparrow Acoustics regarding your use of the Site.

If you opt out or if arbitration is unavailable, disputes will be resolved in the courts of (a) Kent, Delaware (if you are a U.S. resident), (b) Halifax, Nova Scotia, Canada (if you are a Canadian resident), or (c) the appropriate court in Ukraine (if you are a Ukrainian resident).
